NO.GLR(RC)81/2005/Pt/ 15 : In continuation to Notification NO.GLR(RC)81/2005/12, dtd.07-11-2020 the rates of VDA to be paid to the employees/workers employed under the Private Security Agency House are fixed in the basis of 100% rise on average all India CPI for Industrial Workers for the period July/2020 to Dec/2020 (on CPI points average 340.83 base 2016=100) .

And whereas the CPI points number base 2016, has risen by 3.54% points over the average CPI points 329.16 Jan/2020 to June/2020.

Now, it is hereby notified that the following VDA shall be payable to the employees/workers employed under the Private Security Agency House as per table given below w.e.f. 01-01-2021.
